
Plat of Survey A Tract of Land Muhlenberg County, Kentucky



Surveyed Metes and Bounds Description:

Tract 1

A Tract of Land in Muhlenberg County, Kentucky, being more particularly described as follows:

Beginning at an iron pin set at the intersection of the South line of Corum Landing Road and the East line of Ellison Lane; thence along said South line of Corum Landing road 707.67 feet, more or less to a point; thence South 16°05'19" West 232.35 feet to an iron pin set; thence South 13°14'25" West 219.70 feet to an iron pin found; thence South 09°56'50" West 140.72 feet to an iron pin set; thence South 15°26'15" West 139.60 feet to an iron pin set; thence North 66°05'27" West 219.05 feet to an iron pin set; thence North 68°29'05" West 402.57 feet to an iron pin set in the East line of said Ellison Lane; thence along said East line of Ellison lane 602,44 feet, more or less to the Point of Beginning, containing 9.534 acres, more or less.

Subject to any and all rights-of-way, easements, covenants and restrictions, recorded or otherwise.

Tract 2

A Tract of Land in Muhlenberg County, Kentucky, being more particularly described as follows:

Beginning at a stone found at corner common with Osborne, Deed Book 547 Page 676, and Ashley, Deed Book 515 Page 306; thence North 86°11'49" East 653.90 feet to an iron pin found; thence South 85°15'26" East 793.36 feet to an iron pin set in the West line of Corum Landing Road; thence South 00°17'31" East 559.58 feet along the West line of said Corum Landing Road to an iron pin set; thence North 76°44'31" West 217.33 feet to a wood post; thence South 01°51'38" West 480.59 feet to a wood post; thence North 63°48'26" West 207.89 feet to a wood post; thence South 04°36'43" West 194.52 feet to a wood post in the North line of Corum Spur Lane; thence along the North line of said Corum Spur Lane 1290.28 feet, more or less to an iron pin set in the East line of said Ashley; thence North 06°54'03" West 601.38 feet to the Point of Beginning, containing 23.222 acres, more or less.

Beginning at an iron pin set at the intersection of the South line of Corum Spur Lane and the West line of Ellison Lane; thence along said West line of Ellison Lane 564.99 feet, more or less to an iron pin set; thence South 67°19'27" East 30.00 feet to an iron pin set; thence South 29°12'43" West 23.38 feet to a to a point; thence South 09°55'19" West 838.46 feet to an iron pin set; thence South 08°23'33" West 764.14 feet to an iron pin set; thence North 79°02'09" East 179.55 feet to an iron pin set; thence North 86°23'45" East 301.48 feet to a wood post in the North bank of the Mud River; thence along the meanders of said North bank of the Mud River 2946.99 feet, more or less to an iron pin set; thence North 43°56'37" West 330.00 feet to an iron pin set; thence North 20°17'23" West 363.00 feet to an iron pin set; thence North 66°01'40" East 660.00 feet to an iron pin set; thence North 06°54'03" West 1843.61 feet to an iron pin set in the South line of Corum Spur Lane; thence along the South line of said Corum Spur Lane 1765.96 feet, more or less to the Point of Beginning, containing 74.870 acres, more or less.
