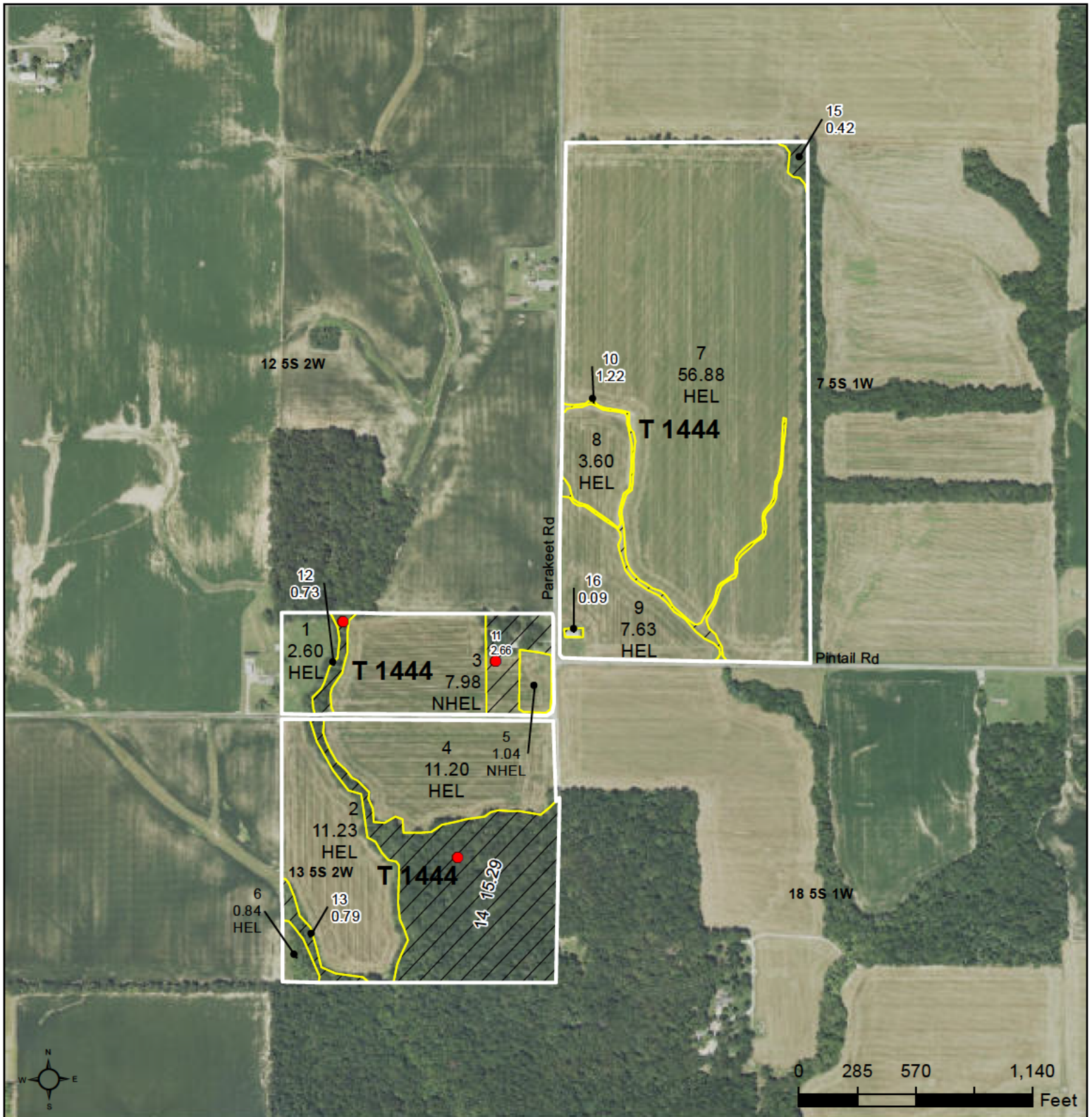

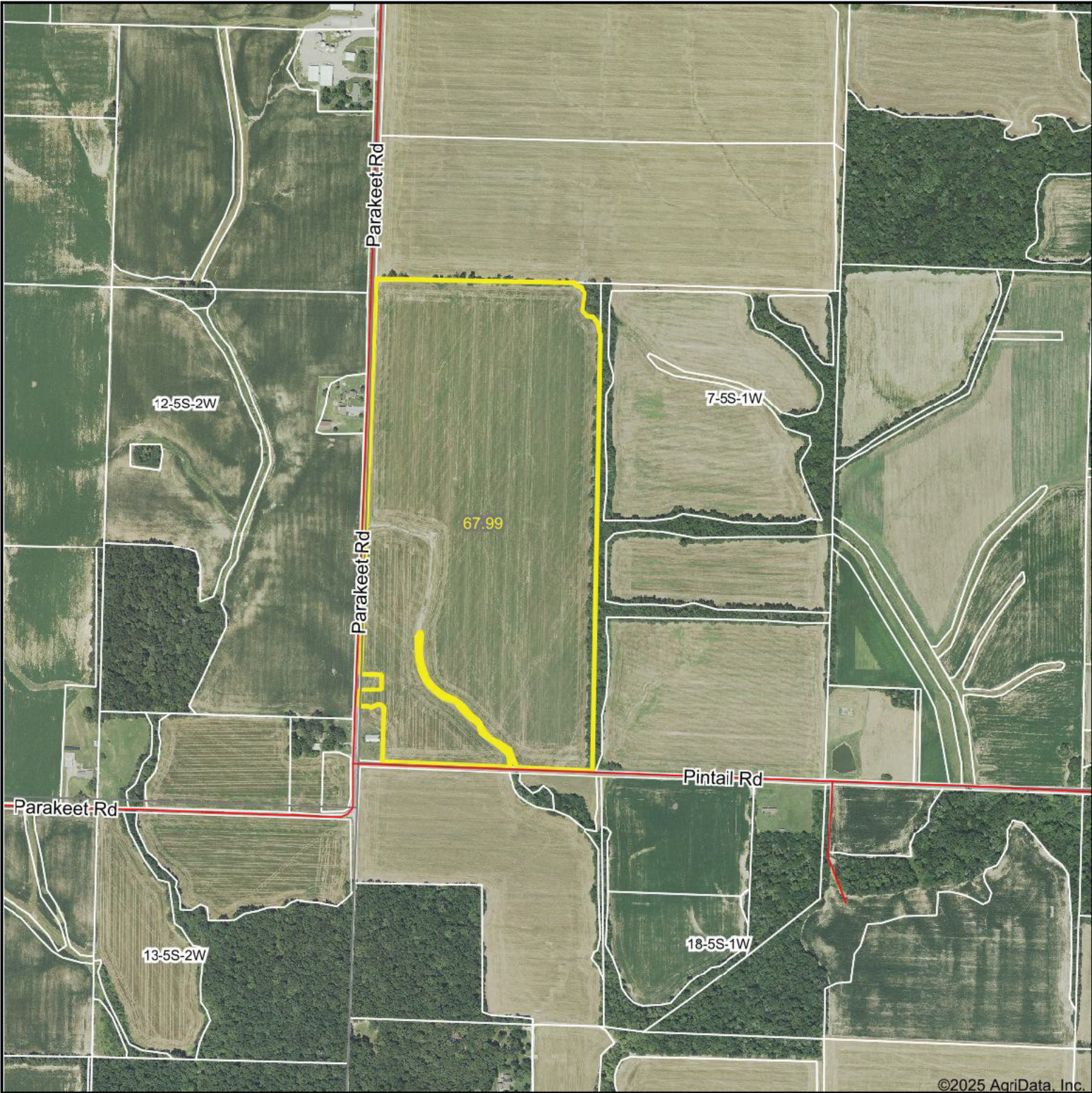

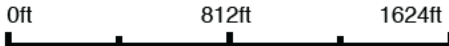
Aerial Map
